

General Conditions of the Summer Course featuring English for Law and an Introduction to the English Legal System

"English for Law" - London, 19th-23rd July 2010 (First Module)

"Introduction to the English Legal System" - London, 26th-30th July 2010 (Second Module)

These general conditions are an integral part of the application form undersigned by the applicant.

1. Description of the Course

The Summer Course featuring English for Law and an Introduction to the English Legal System is made up of two modules (independent of each other):

"English for Law", is a course on legal English designed to teach the basic legal terminology in English ("first module");

"Introduction to the English Legal System", is a legal practice course having as its goal the study of basic notions of the English Legal System ("second module").

The first and second modules, being independent of each other, may also be attended individually.

The subjects to be studied in the first model will include: the English Legal System, European Union Law, Finance Law, Trusts, Criminal Law, Property Law, Commercial Law and Intellectual Property;

those to be studied in the second module will include Contract Law, Property and Conveyancing, Equity and Trusts, Criminal Law and Criminal Procedure, Civil Procedure, Company Law and Tax Law.

Both course modules will be held in London at the Law Society of England and Wales at 100-113 Chancery Lane, London, WC2A.

The course is accredited to the Consiglio Nazionale Forense for the purposes of awarding ECTS credits to participants, as follows:

- first module, 15 credits
- second module, 20 credits.

Participants attending both modules, will be awarded a maximum number of 24 credits.

The actual awarding of credits will be done by the board of the local professional association to which each practitioner belongs, on the basis of the certificate of attendance issued at the end of the course and stating the actual number of hours during which he or she has usefully participated.

The first module of the course will be held from Monday 19th July 2010 to Friday 23rd July 2010, 8:45am -12:20pm, and comprises fifteen hour's discussion.

The second module of the Course will be held from Monday 26th July 2010 to Friday 30th July 2010, 9:00am – 14:30pm, and comprises twenty hour's discussion.

The Course is organised by:

International House London www.ihlondon.com, a school specialised in teaching English for specific purposes (English for Business, English for Law etc.), among other things;

The teachers of the first module of the course are qualified English teachers and also have legal training and experience while the lecturers of the second module of the course are mainly solicitors, barristers, magistrates, university teachers, chartered accountants and public notaries, with the participation of Italian lawyers who practice permanently in England.

The subjects of both modules of the course are going to be dealt with almost completely in English.

The course, which will have an essentially practical aspect, is addressed to lawyers, trainee lawyers, law graduates and law students who are interested in acquiring essential legal terminology in the English language and also basic notions of the English legal system and who have an intermediate level of knowledge of the English language.

At the end of the course the participants will be given an attendance certificate.

A discussion forum devoted to the course has been activated on the website www.gaglione.it/eventi.html . Participants will be able to register and get to know each other before the Course begins and share information of a practical-organisational character, among other things.

The attendance fee for the first module of the course (English for Law, 19-23 July 2010) is GBP £550 (five hundred and fifty), plus VAT, while the fee for the attending the second module of the Course (Introduction to the English Legal System, 26-30 July 2010) is GBP £850 (eight hundred and fifty), plus VAT.

The attendance fee includes registration costs, attending the module of your choice and all the materials provided by the teachers and lecturers which will be distributed at the beginning of each of the modules of the course.

The choice of your accommodation during the course is up to the individual participant.

Registration for one or both modules of the Course can be carried out by sending the application form in by 18th June 2010, as indicated on the form itself.

On the form it will be possible to indicate whether you wish to attend just one module or both the course modules.

After sending in the request, the applicant will receive confirmation of registration with the necessary information for the transfer of the attendance fee. Failure of payment will cancel the registration.

The course is being advertised, organised and carried out in the fullest respect of the Italian Professional Conduct Rules.

In particular, in accordance with art. 17 of said rules, the course is organised and carried out with no aim of profit. With the proceeds from registrations, the Studio Legale Internazionale Gaglione will cover the expenses for running the course (renting the hall from the Law Society, advertising costs, any reimbursement of lecturers etc.).

Any surplus, after the tax, will be used for the constitution and administration of a non profit organisation, having as its principal object the organisation of courses for the study of English Law and the English language. The said organisation, will potentially also see to the setting up of scholarships to be granted to university students who are particularly deserving.

All the documentation, book keeping and administration relating to the course and any further activities of the Studio Legale Internazionale Gaglione, as indicated above, will be kept available for the Consiglio Nazionale Forense for all the appropriate checks.

In keeping with the ethical commitments referred to above, the Studio Legale Internazionale Gaglione has set up a scholarship which will entitle the beneficiary to attend both the first and second modules of the 2010 edition of the course.

This scholarship, founded using the surplus from the registration fees received, after expenses, in relation to the 2009 edition of the course, will be assigned to a university student from the Law Faculty of the Università degli Studi di Firenze.

This Law Faculty will carry out the selection under its own internal procedures, and will be responsible for communicating the references of the student selected to the Studio Legale Internazionale Gaglione.

2. Contract of Participation

The application form amounts to an irrevocable offer for a term of 30 working days. in case of an acceptance of the application, the applicant will receive written confirmation, by post, fax or electronic post, with the necessary information for the transfer of the attendance fee. Failed payment will lead to the cancellation of registration.

3. Fee

The attendance fee for the first module of the Course (English for Law, 19-23 July 2010) is GBP £550 (five hundred and fifty), plus VAT, while the fee for the attending the second module of the Course (Introduction to the English Legal System, 26-30 July 2010) is GBP £850 (eight hundred and fifty), plus VAT.

The fee will be invoiced by the organisers of the course. A invoice attesting receipt of payment will be sent to the applicant upon the payment of the attendance fee as per the above clause. The fee covers only the attendance fee and any materials which will be distributed at the start of each of the modules of the course and does not include travel, board and accommodation.

4. Changes to the course and minimum number of participants

While the general curriculum of both modules of the course will not be subject to any change, and neither will the dates or the location where the lessons and sessions will take place, or the fee, there may be alterations to the individual subjects to be studied, lecturers, lecturer-subject combinations and/or minimum number of participants, subject to organizational requirements, and these may undergo changes, substitutions, and/or supplementation in the period prior to the date of the effective start of each module of the course.

Each module of the course may be cancelled should the minimum number of participants (twenty) not be achieved by the 18th June 2010 or for any other serious reasons. The participant will be informed in writing should one or both the modules of the course be cancelled and the full fee paid will be returned immediately.

5. Applicant's right to withdraw

The participant will be able to withdraw from the contract of participation by sending the Studio Legale Internazionale Gaglione, 35 Piccadilly, W1J 0DW London, United Kingdom, written withdrawal notice within 10 (ten) working days from date of receipt of confirmation, as per point 2 above. Such notice can be sent by fax or by electronic post and must be confirmed within the next forty eight hours by registered mail. The participant will thus be released from the contract of participation and if necessary the fee paid will be returned within thirty days of receipt of notice, less the flat rate of GBP £55 (fifty five) for refund of expenses.

6. Treatment of personal information

Personal information communicated by the participants will be subject to processing by the organisers of the course only for purposes which are relevant to the course and will not be communicated nor distributed to third parties.

7. Applicable Law

The Contract of Participation will be subject to English Law.
